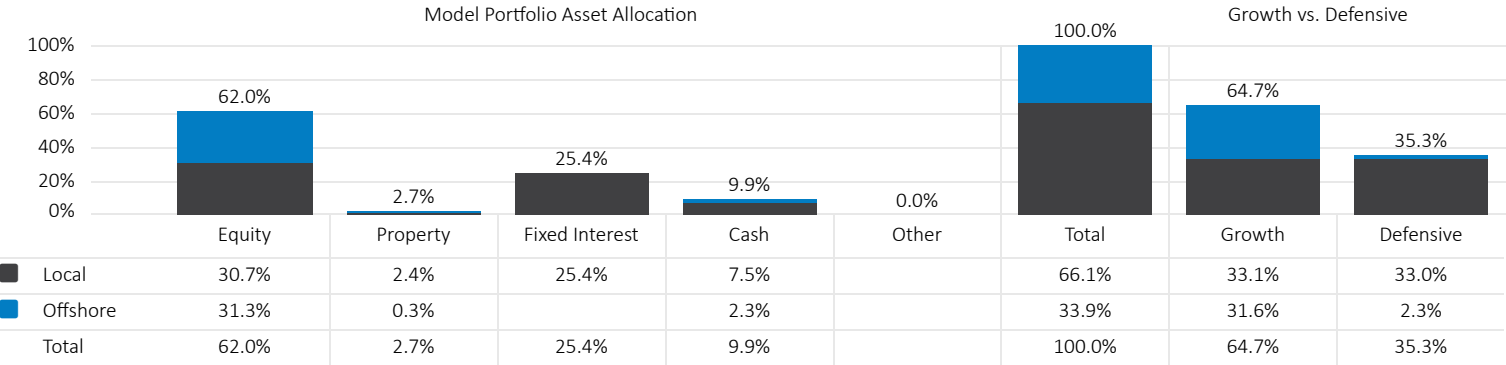


OBJECTIVE						INVESTMENT GUIDELINES
