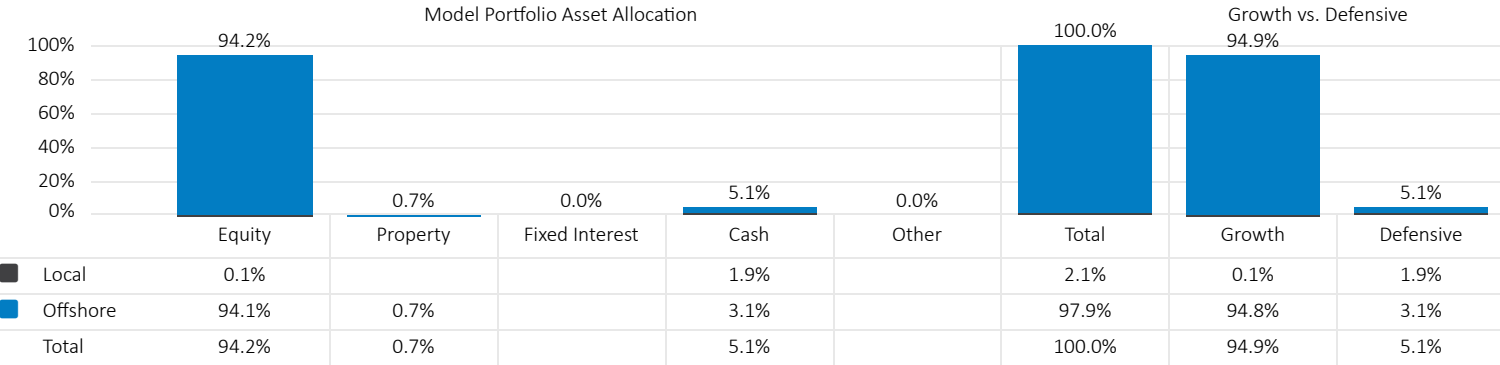


OBJECTIVE						INVESTMENT GUIDELINES	
This is an equity growth fund which delivers real returns to clients through exposure to offshore asset classes such as equity and property in both developed and emerging markets. The aim of the portfolio is to generate high levels of capital growth over long term investment horizons. The returns are generated in rands, and as such investors are exposed to the fluctuations of the Rand where a weakening rand serves to boost local returns.
