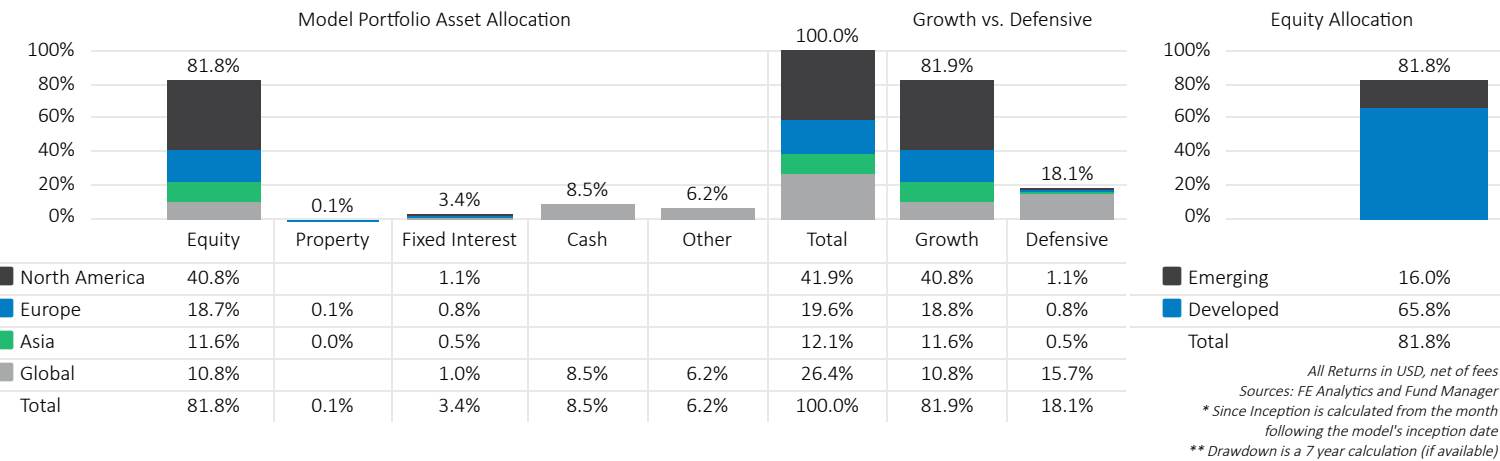


OBJECTIVE	INVESTMENT GUIDELINES
